

SF Bay Area Housing Finance Authority Act: Legislation Refresher

- Counties and direct-allocation cities must prioritize new construction investments that help achieve ELI, VLI and LI RHNA targets
 - County/city must demonstrate compliance in their written expenditure plans
 - For all Bay Area counties, about 45% of RHNA obligations are for ELI (<=30% AMI) and VLI (<=50% AMI) housing
 - About 26% of RHNA is for LI housing (<=80% AMI)







Legislative Update – AB 1319 (Wicks, 2023)

- Adds "homelessness prevention services" to eligible tenant protection expenditures:
 - Emergency financial assistance
 - Supportive services
 - Housing problem solving
 - Residents without leases can be served
- Adds "nonprofit corporations" to list of entities to which BAHFA can allocate funds







Legislative Update – ACA-1 (Aguiar-Curry, 2023)

- Lowers voter approval threshold for bonds from 2/3rds to 55% for "...affordable housing, or permanent supportive housing for persons at risk of chronic homelessness, including persons with mental illness..."
 - "Affordable housing" as defined includes capitalized operating reserves
 - ACA 1 likely to be amended







Putting It Together

BAHFA FUNDS

- Must prioritize ELI/VLI Housing
- Apply & leverage:
 - PB Sec. 8 full FMRs and shallow subsidies
 - MHSA, NPLH, S+C, VASH, etc.
 - Mixed-income models

ACA 1

May add new COSR and other support opportunities via amendments

REGION-WIDE

- Commit to serious cost control practice and increase production
- Employ proven models of time/cost goals driving all design decisions








New ELI units needed to reach RHNA (2023-2031) target*

^{*} ELI targets calculated as 50% of VLI goals following HCD's <u>guidance</u> to "Presume that 50 percent of very low-income households qualify as ELI households." ABAG regional ELI goal (set at 15.5% of total new units needed) is closer to 60% of VLI regional target.

Annual new VLI units needed to reach RHNA goal (current cycle) versus average VLI units completed (last cycle)*



^{*} Annual units needed = total VLI allocation divided by eight (the number of years in the RHNA cycle).

Data for average units produced is from HCD's Housing Element Implementation and APR Data Dashboard for years 2018-2022.
