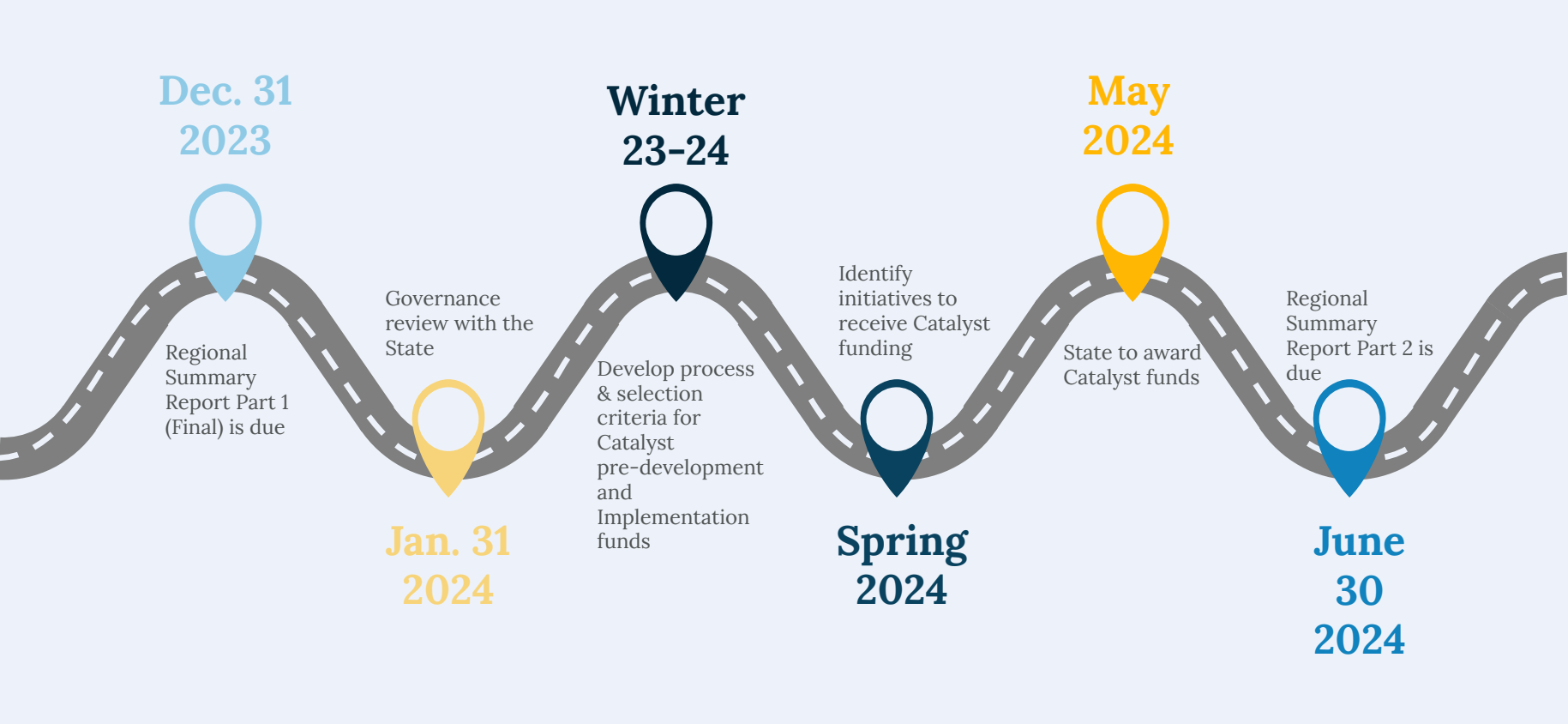
2023 Accomplishments

★ Executed contract with SF Office of Economic & Workforce Development (SF OEWD)	April 2023
★ Created and submitted Planning Phase Plan document	April - June 2023
★ Continued developing inclusive governance structure: <ul style="list-style-type: none">○ Launched six sub-regional tables in the Bay Area○ Launched the Research, Planning and Community Engagement Committee○ Developed bylaws, working groups, co-chairs and more to help guide our work	June 2023 October 2023
★ Learned about and incorporated Catalyst 2.0 Program; including submitted Catalyst 2.0 application for \$14M in funding	August 2023 - November 2023
★ On track to submit Regional Summary Report Plan Part 1	December 2023
